This is in reference to the Clause no. 17, "Appeal" of TEC Scheme for designation of Domestic Conformity Assessment Bodies (CABs) and Certification Bodies vide **Issue 3: No. TEC 04019:2023.**

- 2. Designated CABs/CBs seeking appeal against the decision taken by DA with regard to suspension or withdrawal of designation of CABs/CBs, may send the appeal to **DDG** (**Mobile Technologies**) **TEC**, (designated as Appeal officer) in writing or on e-mail **ddgm.tec@gov.in**
- 3. The CAB/CB not satisfied with the decision of TEC regarding non acceptance of their application for designation, refusal to grant/renew designation, Suspension/Withdrawal of their designation or any other action that impedes the process of attainment of designation, may file appeal to **DDG** (Mobile Technologies), TEC (designated as Appeal officer) in writing or on e-mail ddgm.tec@gov.in within 30 days from the date of issue of such decision(s) of DA.
- 4. Initially the appeals shall be examined by designated Appeal Officer for its validity and if prima-facie these appear to be valid and having some substance, that will be taken up for further actions or otherwise the appellant will be informed appropriately. Appeals Officer shall acknowledge the receipt of appeals.
- 5. Admitted appeals shall be placed before the designated Appeals Committee and the Appeal committee shall make the final decision within a reasonable period of time and the Appellant shall be informed accordingly by Appeal Officer.
