Objective and rationale, including the nature of urgent problems where applicable:</b> Definition of minimum cybersecurity requirements for conformity assessment of CPE (Customer Premises Equipment) equipment.  CPE equipment distributed in the national market has the default authentication configuration vulnerability. This vulnerability, which consists in the factory configuration of authentication passwords that are the same among all equipment units produced, allows malicious agents to easily access the equipment configuration environment via the internet and take control of those CPEs that have not had their default passwords changed. Such intrusions can result in the compromise of information (personal, banking,

<p>etc.) of users of telecommunications services, in addition to allowing such CPEs to be used as vectors in denial of service attacks or other types of cyber-attacks.; Quality requirements</p>
