Description of content: Notice is hereby given by the Ministry of Innovation, Science and Economic Development Canada that the following has been published: <ul style="list-style-type: none">• <i>RSS-102, SPR-002, Issue 2 – Supplementary Procedure for Assessing Compliance of Equipment Operating from 3 kHz to 10 MHz with RSS-102</i> which sets out the technical requirements and assessment procedures for demonstrating compliance of radio apparatus with the radiofrequency (RF) exposure limits outlined in RSS-102 from 3 kHz to 10 MHz. It applies to all radio apparatus producing RF emissions in this range. It also applies to some interference-causing equipment, specifically Industrial, Scientific and Medical (ISM) equipment.
