Telecom Standards Advisory Committee (TSAC) – a Standing apex committee under the chairmanship of DDG (Standardisation), TEC in its meeting held on 18-07-2023 has decided to initiate the process of adoption of **TSDSI adopted ATSC 3.0 standards into national standards by TEC.**
