PUBLIC CONSULTATION Nº 63

Introduction

The Regulation on Local Areas for STFC (approved by Resolution No. 560, of 2011) provides for the obligation for Anatel to carry out the annual review, with a view to granting local treatment or expanding the local area to locations that may meet the requirements urban continuity provided for in the Regulation.

"Art. 8 The review resulting from the provisions of items II and III of article 7 of this Regulation shall be carried out by Anatel, periodically, every 12 (twelve) months, counting from the date of publication of this Regulation, by means of Consultation § 1° The review provided for in the caput will be approved by Decree Order of the Superintendent responsible for the regulation process. (...) " [Wording given by Resolution no 728, of June 1, 2020]

In turn, the art. 7 of the Regulation establishes, in its items II and III, the criteria to be observed for the purpose of providing the STFC, emphasizing that the situations of local area and local treatment must be motivated due to urban continuity or by reasoned request from the local concessionaire of the service.

Resolution No. 728, of June 1, 2020, introduced significant changes to the Regulation on Local Areas for STFC, among which we highlight:

- i) the provision for Public Consultation for annual reviews of Local Areas / Local Treatment of the STFC; and
- ii) the change in the competence of these reviews, which are then approved by the Superintendent responsible for the regulatory process (the SPR).

It should be noted that the regulation deals expressly on the topic, since it admits the review of local areas based on technical criteria previously defined in a specific standard. Thus, it is up to the technical area to only carry out the appropriate technical analyzes based on the regulatory criteria and make the corresponding adjustments.

For these reasons, it is not possible to carry out a Regulatory Impact Analysis in these reviews, since the regulation provides the conditions under which such changes should occur. In fact, the only possible alternative is to comply with the standard, with no possibility of not carrying out the Annual Review of Local Areas of the STFC.

Thus, this Public Consultation deals with the annual review of Local Areas of the STFC, referring to the year 2020, already within the competence of the Superintendent of Planning and Regulation, considering the amendments to the Regulation on Local Areas for the STFC, which were introduced by <u>Resolution No. 728</u>, of <u>June 1</u>, 2020.

Arara and Santa Fé, located in the municipalities of Arara / PB and Solânea / PB, respectively.
