## Notice for Inviting Public Comments

**Subject:** - Inviting public comments for adoption of TSDSI Standard "Common Data Payload for Adaptive Traffic Control Systems and Other Intelligent Transportation System Products" as a National standard by Telecommunications Engineering Centre (TEC) – reg.

Telecommunication Engineering Centre (TEC), Department of Telecommunications (DOT) has approved a policy for the adoption of domestic/international standards into National Standards. "Standardisation Guide" – a policy document for the adoption of telecom and related ICT standards defines the process of adoption/ratification of TSDSI/international standards including institutional mechanism, process of adoption, maintenance of standards, numbering plan, stakeholder consultation etc. The Standardisation Guide can be accessed at <a href="https://tec.gov.in/standards-adoption-policy">https://tec.gov.in/standards-adoption-policy</a>.

2. The Telecom Standards Advisory Committee (TSAC) - a standing apex committee chaired by DDG (Standardisation) TEC, has decided to extend the public consultation period by an additional 30 days. This is to ensure full compliance with the mandatory 60-day consultation requirement under Clause 5(1) of the Telecommunications (Standards, Conformity Assessment and Certification) Rules, 2025, notified via Gazette Notification G.S.R. 315(E) dated 16th May 2025. TEC, Department of Telecommunications (DoT), had earlier invited public comments on this proposal during the period 19.11.2024 to 19.12.2024.

3. All stakeholders are now requested to offer their comments during this extended
